This week, President Trump announced support for my legislation in the House budget reconciliation bill that would give children born in the United States \$1,000 investment accounts. That's why it is critical that we properly harness the power of artificial intelligence—ensuring the U.S. continues to lead the world in growth, job creation, development, and production.

As Chairman of the Commerce Committee and as your Senator, I remain committed to ensuring that Texas has the resources it needs to stay at the forefront of AI development in America. I will fight to ensure the United States remains the global leader in AI.

My office received over 1000 applicants for the Class of 2029, and the top 200 candidates were reviewed by my Academy Review board, resulting in 35 nominations and appointments from the academies. On Saturday, I visited with 21 of those nominees and thanked them for their willingness to serve the country as they prepare to start classes at the Academies this Summer.
